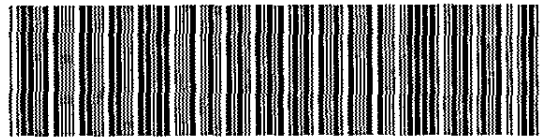



ARTICLE VI - ADDITIONAL CAPITAL CONTRIBUTIONS

ARTICLE VII - ADMISSION OF NEW MEMBERS
