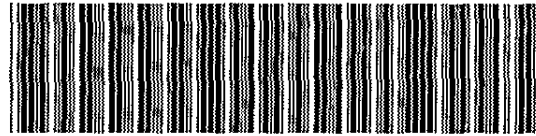

SECOND: This amendment is submitted to amend the following:

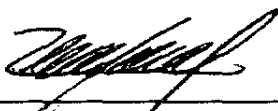
Article IV of the Articles of Organization shall be amended and restated as follows:
