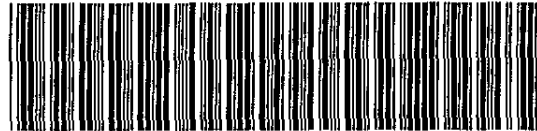




**ARTICLE V**  
**ADMISSION OF ADDITIONAL MEMBERS**


Members shall the right to admit additional members as provided by the Florida Limited Liability Act by a vote of a majority-in-interest of the members.
