ARTICLES OF ORGANIZATION OF TRI 3 RACING, L.L.C.

ARTICLE I

Name

The name of the limited liability company ("Company") is TRI 3 RACING, L.L.C.

ARTICLE II

ARTICLE V

Management

The Company is to be managed by managers. The initial managers will serve until the first annual meeting of the members or until the managers' successors are elected and qualified. The initial managers are identified as MATTHEW C. HESS, 3355 Fox Hill Drive, Clearwater, Florida 33761, and DONNA BROWN McMULLEN, 900 Harbor Island, Clearwater, Florida 33767.

ARTICLE VI

Admission of Additional or New Members

Members of the Company have the right to admit new members. Additional or new members may be admitted only on the unanimous written consent of the existing member or members, and the existing member or members shall determine the amount and nature of contributions to be made by the additional or new members at the time those new members are admitted.

ARTICLE VII

Continuance of Business

The remaining member or members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be continued only on the unanimous written consent of the remaining member or members.

ARTICLE VIII

Additional Provisions

The power to adopt, alter, amend or repeal the regulations of the Company is vested entirely in the manager listed in Article V.
