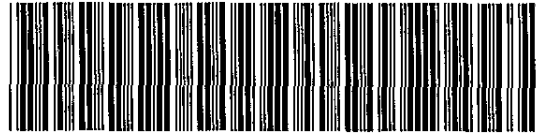

**ARTICLE I: NAME**

The name of the limited liability company is: **PATRICIA P. WOOD, LLC.**

**ARTICLE II: ADDRESS**

**ARTICLE III: DURATION**

The period of duration of the Company is perpetual.

**ARTICLE VI: PURPOSES AND POWERS**

To carry on any business and to have all the powers authorized by the laws of the State of Florida for limited liability companies.

**ARTICLE V: REGISTERED AGENT AND OFFICE**

**ARTICLE VII: ADMISSION OF NEW MEMBERS**

Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to the limited liability company.

A member's interest in the limited liability company may not be sold or otherwise transferred except with unanimous written consent of all members.


On the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or the occurrence of any other event that terminates the continued membership of a member in the limited liability company, the remaining members shall have the right to continue the business on unanimous consent of the remaining members.

**ARTICLE VIII: ADDITIONAL PROVISIONS**

A. AMENDMENTS: The power to adopt, alter, amend, or repeal the regulation of the Company is vested entirely in the Members, and requires unanimous consent thereto.

B. COMPANY TO BE TREATED AS A SINGLE MEMBER UNIT ENTITY DISREGARDED FOR FEDERAL INCOME TAX PURPOSES. To the fullest extent permitted by law the Company elects to be treated as a single member unit entity, so as to be disregarded for the purposes of federal income tax, the income to "pass through" the Company and to be taxable to the single member unit.

The undersigned, being the original member of the limited liability company, certifies that this instrument constitutes the Articles of Organization of **PATRICIA P. WOOD, LLC**.





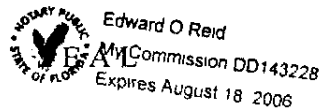
