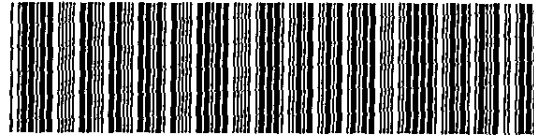

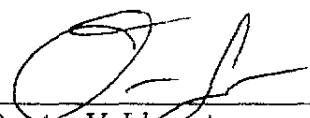
## ARTICLES OF DISSOLUTION OF LIMITED LIABILITY COMPANY

In accordance with Section 608.445 of the Florida Limited Liability Company Act, the undersigned executes these articles of dissolution and states the following:

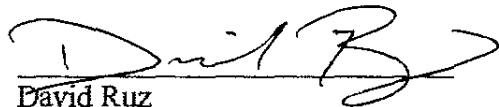
1. The name of the limited liability company is Genuine Trust Appraisal LLC, a limited liability company organized under the laws of the State of Florida ("Company").
