ARTICLES OF ORGANIZATION NORTH BAY ENGINEERING, L.L.C.

The undersigned certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit.

We further declare that the following Articles will serve as the Charter and authority for the conduct of business of the limited liability company.

ARTICLE I

Name and principal place of business. The name of the limited liability company shall be NORTH BAY ENGINEERING, L.L.C., and its mailing address and principal office shall be located at 401 Landings Drive, Lynn Haven, Florida, 32444, but it shall have the power and authority to establish branch offices at any other place or places as their members may designate.
