The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

### ARTICLE 1 - Name

The name of the limited liability company shall be GLEN THOMAS LANDSCAPING, LLC, (hereinafter "Company").

# ARTICLE 2 - Address of Company

# ARTICLE 4 - Managers

Subject to the limitations set forth in the Operating Agreement, if any, the business and affairs of the Company shall be managed by one Manager, appointed in Agreement of the Company, who may exercise all powers of the Company and perform or authorize the performance of all lawful acts which are not otherwise prohibited by law, the Operating Agreement or these Articles of Organization. # ARTICLE 5 -Term of Existence and Members Rights to Continue Business
