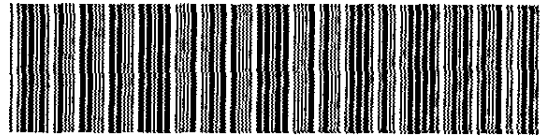



**ARTICLES OF ORGANIZATION  
FOR  
G&J Home Improvement, LLC**

The undersigned, for the purpose of forming a limited liability company under the laws of the State of Florida, hereby adopts the following Articles of Organization:

**ARTICLE I  
(Name)**

The name of the limited liability company is G&J Home Improvement, LLC ("the Company").

**ARTICLE II  
(Address)**

The principal office and street mailing address of the Company will be located at 10305 Triple Crown Avenue, Jacksonville, Florida 32257.

**ARTICLE III  
(Duration and Continuation)**

The Company shall have perpetual existence, commencing upon April 13, 2004, or such other date no more than five (5) days prior to the filing of these Articles of Organization with the Florida Department of State, whichever is later.

**ARTICLE IV  
(Purpose)**

The general purpose of the Company and the nature of the business to be transacted by the Company are to engage in any and all activities and exercise any and all powers, rights, and privileges for which a Company may now or hereinafter be organized under the laws of the State of Florida.

**ARTICLE V  
(Registered Agent and Office)**

The street address of the initial registered office of this Company is 10305 Triple Crown Avenue, Jacksonville, Florida 32257, and the name of the initial registered agent of this Company at that address is Gevargiz Yousefzadeh.

**ARTICLE VI  
(Additional Members)**

Additional members may be admitted as provided in the Operating Agreement of the Company.

**ARTICLE VII**  
**(Members' Rights to Continue Business)**

The right, if given, of the remaining members of the Company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event that terminates the continued membership of a member in the Company will be as provided in the Operating Agreement of the Company.

**ARTICLE VIII**  
**(Members' Preemptive Rights)**

All members shall have preemptive rights with respect to any units by the company subsequent to the date on which such member purchased his or her units. The preemptive right of each individual member shall entitle such member to purchase a percentage of the units to be issued by the company such that his or her proportionate ownership interest in the company will remain the same.

**ARTICLE IX**  
**(Management)**

The Company affairs will be conducted, carried on, and managed by one (1) or more members and is therefore a member-managed company. The manager will have the obligations and responsibilities described in the Operating Agreement of the Company. The name(s) of the initial member-manager(s) is/are: Gevargiz Yousefzadeh,. The manager(s) will serve in that capacity until removed by the members or until his or her successor(s) is/are duly elected and qualified.

**APPOINTMENT OF REGISTERED AGENT**

The undersigned, G&J Home Improvement, LLC, a Florida limited liability company, with its principal offices in Duval County, Florida, hereby appoints Gevargiz Yousefzadeh as its statutory agent upon whom any process, notice or demand required or permitted by statute to be served upon the undersigned may be served. 
