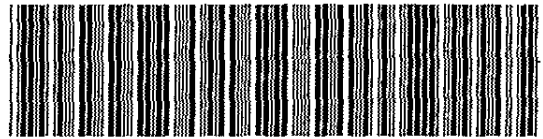





B. Jack P. Hartog shall be the Managing Member and President of the LLC. His address is the same as the LLC.


