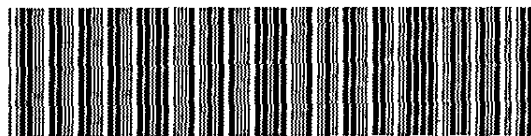

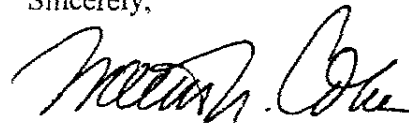

CHANDIT, LLC**

**ONE**
