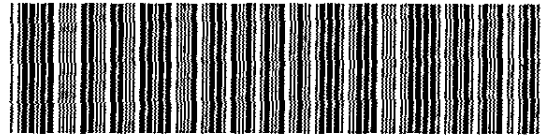



The name of this Limited Liability Company shall be **ANDREW CONSTRUCTION SERVICES, L.L.C.**


