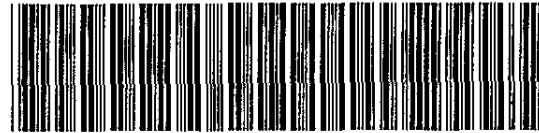

ARTICLES OF ORGANIZATION
OF
LUCKY 13 DESIGN STUDIO, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability corporation is LUCKY 13 DESIGN STUDIO, LLC

ARTICLE II - PRINCIPAL OFFICE

The principal place of business of this limited liability corporation shall be 1455 Martinique Court Suite 6513, Weston, FL 33326

ARTICLE III - DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The company's existence shall terminate not later than December 31, 2033 unless the company is earlier dissolved as provided in these Articles of Organization.

ARTICLE IV - PURPOSE AND POWERS

The general purpose for which the corporation is organized to operate a design and advertising business as well as any lawful business for which a limited liability company may be organized under the laws of the state of Florida. The company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

The Company shall be dissolved upon the death, requirement, resignation, expulsion, bankruptcy, or dissolution of a member of manager, or upon the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all remaining members, provided there are least two remaining members.

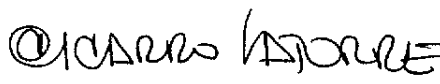

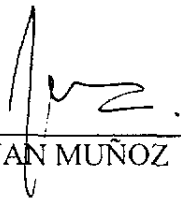
