# ARTICLES OF ORGANIZATION

OLARAZI M. 8:39 We, the undersigned, hereby execute these Articles of Organization for the pur organizing a limited liability company under the laws of the State of Florida.

## ARTICLE I

The name of the limited liability company is ZDJW PROPERTIES, LLC.

# ARTICLE II

The mailing address of the limited liability company shall be 11228 St. Johns Industrial Parkway, Jacksonville, Florida 32246, and its street address is the same.

# ARTICLE III
