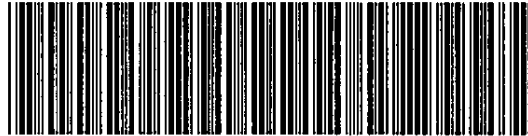




1. The name of the limited liability company is **ZDJW PROPERTIES, LLC**.
