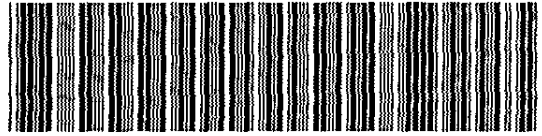

**Articles of Organization
of
The Katana Group, LLC**

THESE ARTICLES OF ORGANIZATION forming a limited liability company under the laws of the State of Florida are made and executed this 4/17 day of 2004, by the undersigned.

1. **Name.** The name of the limited liability company is The Katana Group Limited Liability Co. (hereinafter referred to as the "Company").

2. **Term.** The term or period of duration of the Company shall commence as of the date of the filing of these Articles of Organization with the Florida Division of Corporations and shall continue unless sooner terminated pursuant to law or the provisions of the Company's Operating Agreement.

3. **Business Purpose.** The character and purposes of the Company and its business are (1) real estate development; (2) to engage in any lawful act or activity for which companies may be organized under the Florida Limited Liability Company Act; (3) to do everything necessary, proper, advisable, or convenient for the accomplishment of any of the purposes, or the attainment of any of the objects, or the furtherance of any of the powers herein set forth, either alone or in association with others, and incidental or pertaining to, or growing out of, or connected with, its business or powers, provided the same is consistent with the laws of the State of Florida.

4. **Registered Office and Agent.** The street address of the Company's registered office is 13874 SW 40th Street, Davie, Florida 33330. The name of the Company's initial registered agent at that address is Darris W. Allen.

5. **Principal Office.** The mailing address of the Company's principal office is 13874 SW 40th Street, Davie, Florida 33330. The name of the Company's initial registered agent at that address is Darris W. Allen.

6. **Management.** The Company shall be managed by its members.

7. **Members.** This company shall initially have two (2) Members upon formation and will always maintain at least two (2) Members. New Members may be added to the Company only with the unanimous consent of all the existing Members. If

a Member sells or assigns an interest in the Company, the purchaser or assignee is entitled to all of the financial rights of the selling or assigning Member in the Company. The purchaser or assignee is permitted to participate in the management of the Company without the consent of a majority of the non-selling Members.

8. **Amendment.** The power to amend, alter or repeal these Articles of Organization shall be vested in the members. The Articles of Organization may be amended at any time and in any manner by the unanimous written agreement of all the Members.

9. **Informal Action of Members.** Any action of the Members may be taken without a meeting if consent in writing setting forth the action so taken shall be signed by all members who would be entitled to vote upon such action at a meeting and filed with the Company as part of its official records.
