The undersigned, for purposes of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and FIESSEE, FLORIDA the following Articles of Organization.

ARTICLE I - NAME

The name of the Limited Liability Company is: CITY CENTRE ORLANDO, LLC.
