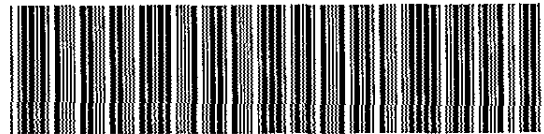

ARTICLES OF ORGANIZATION
OF

The undersigned, being a natural person of eighteen years of age or more and desiring to form a limited liability company under the laws of the state of Florida, does hereby sign and deliver in duplicate to the Secretary of State of Florida these Articles of Organization.

ARTICLE I


NAME

The name of the limited liability company shall be O.K. Fine ,L.L.C. The limited liability company is hereinafter referred to as the "Company".

CONTINUATION
