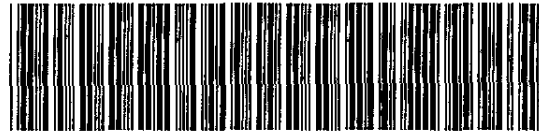

The name of the Limited Liability Company is JFJ Holdings, L.L.C.

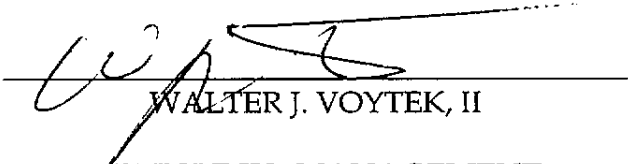
