

ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF

924 NE 17TH TERRACE, LLC, A FLORIDA LIMITED LIABILITY COMPANY



- 1. The original Articles of Organization (the "Articles") for 924 NE 17TH TERRACE, LLC, a Florida Limited Liability Company (the "Company"), were filed on April 22, 2004, with the Secretary of State of Florida.
 - 2. The original Articles are hereby amended as set forth herein.
 - 3. Article III is deleted in its entirety and the following is substituted:

ARTICLE III

PURPOSE

The sole purpose of the Company is to own, manage and operate the property known as the "Somers Apartments" located at 924 N.E. 17th Terrace, Fort Lauderdale, FL 33304 (the "Property").

ARTICLE VII

Article VII is hereby added with the following:

PROHIBITIONS

- A. The Company's ability to incur indebtedness is limited to incurring (1) the indebtedness to Wells Fargo Bank Minnesota, N.A. (f/k/a and successor by merger to Norwest Bank Minnesota, National Association), as Trustee for the Registered Holders of Salomon Brothers Mortgage Securities VII, Inc., Commercial Mortgage Pass-Through Certificates, Series 2000-C1 (the "Lender"), by and through GMAC Commercial Mortgage Corporation, as Master Servicer and Special Servicer (the "Loan"), and (2) liabilities in the ordinary course of business relating to the ownership and operation of the Property located at the Property.
- B. The Company (and, as applicable, its members and affiliates) shall not engage in or cause its dissolution, liquidation, consolidation, merger or asset sale, or amendment to its Articles of Organization as long as the Loan is outstanding.
