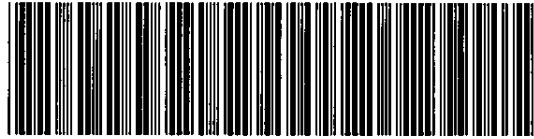

The founding member or his appointee shall have the right to admit additional members as provided by the Florida Limited Liability Act.


