The Members may permit the admission of Additional Members, upon the unanimous consent of all Members of the Company.


ARTICLE VI - CONTINUATION OF BUSINESS

The Company shall be managed by its Members.

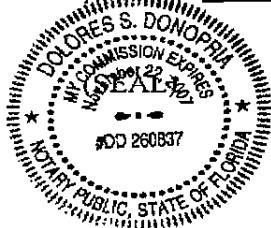
