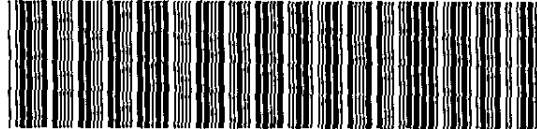

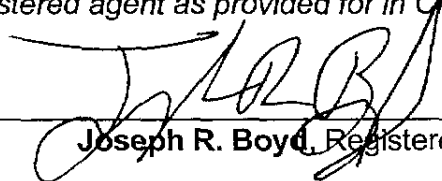
The purpose for which this professional limited liability company is formed is to engage in the general practice of law.

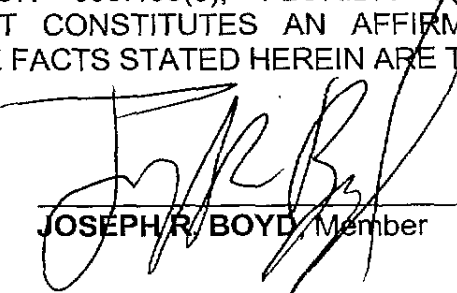
