### ARTICLES OF ORGANIZATION

SECRETARY OF S The undersigned, for the purpose of forming a limited liability company under the Limited Liability Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

# **ARTICLE I - NAME**

The name of the limited liability company (the "Company") shall be SPRUCE ROAD, L.L.C.
