FIRST: The name of said Limited Liability Company shall be, GRAND FLORIDA HOMES, LLC, and the mailing address and the street address of the principal office of the limited liability company shall be: 560 N.E. 103rd Street, Miami Shores, Florida 33138.

SECOND: GRAND FLORIDA HOMES, LLC, shall have a perpetual duration from the date of filing of these Articles of Organization.
