ARTICLES OF ORGANIZATION
OF
DAN-ZAR NURSERY & TREE FARM, LLC

The undersigned organizer hereby forms a Limited Liability Company under Chapter 608 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the Limited Liability Company ("Company") shall be:

DAN-ZAR NURSERY & TREE FARM, LLC

ARTICLE II. PRINCIPAL PLACE OF BUSINESS




