ARTICLES OF ORGANIZATION OF T & T HOLDINGS, L.L.C.

ARTICLE I

The name of the Limited Liability Company ("Company") is

T & T HOLDINGS, L.L.C.

ARTICLE II PRINCIPAL PLACE OF BUSINESS

The principal place of business and mailing address of the Company is 960 17th Street; Suite 105, Vero Beach, Plorida 32960 or such a place as may be designated by the Members.

ARTICLE IV PURPOSE

The purpose and character of the Company is to acquire, invest in, own, maintain, repair, lease, sell and otherwise use property and equipment in the performance of imaging diagnostic procedures and other personal property related or incidental thereto, and in connection with this purpose, and other activities related or incidental thereto, including without limitation, the borrowing of funds and the granting of security interests in its property. The Company shall have all powers granted to Limited Liability Companies under Florida Law.

ARTICLE V DURATION

The Company shall perpetually continue in full force and effect from the due of filing these Articles of Organization with the Secretary of State, or until dissolution prior thereto pursuant to the provisions hereof and upon filing of Articles of Dissolution with the Secretary of State pursuant to Florida Statutes 608.441.

ARTICLE VI MANAGEMENT

The Company shall be managed by its Members in proportion to their Sharing Ratios (herein so called) of each initial Member as set forth in the Operating Agreement for the Company, and as adjusted from time to time to reflect the Sharing Ratios of any additional Members; provided, however, that the Members may, by revising the operating agreement, provide for the management of the Company by the Members in a manner disproportionate to the Members' Sharing Ratios adjusted as hereinabove set forth. ARTICLE VII ADDITIONAL MEMBERS

Additional Members may be admitted to the Company only upon the unanimous vote of the existing Members. New Members may be admitted upon such zeros and conditions as the existing Members may determine.

ARTICLE VIII DISSOLUTION

In the event of the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or upon the occurrence of any other event of dissolution as the Members may specify by regulation or operating agreement, which terminates the continued membership of a Member in the Company, the Company shall be dissolved unless within thirty (30) days after such event, unless the remaining Members agree in writing to continue the business of the Company.

ARTICLE IX INDEMNIFICATION

The Company shall, to the fullest extent permitted by law, be entitled to indemnify and Member for any liability incurred in connection with any action, if such Member acted in good faith and in a manner it reasonably believed to be in furtherance of, or not opposed to, the best interests of the Company. The Company shall indemnify any person who is or was a party, or who is threatened, pending, or completed action, suit or proceeding, whether civil, criminal, administrative or investigative, including all appeals, by reason of the fact that he or she is or was a Member, Managing Member or employee of the Company, or is or was serving at the request of the Company as a director, trustee, officer or employee of another limited liability company, corporation, partnership, joint venture, trust or other enterprise, against any and all expenses (including reasonable attorneys' fees), judgments, decrees, fines, penalries and amounts paid in sertlement, which were actually and reasonably incurred by him or her in connection with such action, suit or proceeding, if he or she acted in good faith and in a manner which he or she reasonably believed to be in, or at least not opposed to, the best interests of the Company, and with respect to any action, suit or proceeding, he or she had no reasonable cause to believe his or her conduct was unlawful. The termination of any action, suit or proceeding by judgment, order, sertlement conviction, or plea of nole contenders or its equivalent shall not, of itself, create a presumption that the person did not act in good faith and in a manner which he or she reasonably believed to be in, or at least not opposed to, the beast interests of the Company.

ARTICLE X LIMITATION OF LIABLITY OF MEMBERS

The personal liability of the Members to the Company and other Members shall be limited to the maximum extent allowed by Florida law and there shall be no Member who is personally liable for the debts of, or claims against, the Company.

ARTICLE XI TRANSFERABILITY OF INTEREST

No Member of the Company may transfer or assign its interest in the Company without the prior written consent of all of the other Members. Any attempt to transfer or assign a Member's interest, without such a written consent, shall not entitle the transferre to participate in the management of the business and affairs of the Company or to become a Member. The transferre shall be only entitled to receive the abare of profits or other compensation by way of income and the return of contributions to which the Member otherwise would be entitled.

ARTICLE XII POWER TO AMEND

The power to adopt, alter, amend or repeal the Assicles of Organization of the Company shall be vested solely in the Members of the Company and shall be by a unanimous vote of approval of the Members.

ARTICLE XIII LIMITED LIABILITY COMPANY REGULATIONS

The power to adopt, after, amend, or repeal the Operating Agreement of the limited liability company shall be vested in the Members of the Company. The Operating Agreement adopted by the Members may be repealed or aftered; the Members may adopt a new Operating Agreement, and the Members may proscribe any changes made by them that such changes to the Operating Agreement may not be altered, amended, or repealed by the Manager Member(s) or Managers. The Operating Agreement may not contain provisions for the operation and management of the affairs of the limited liability company inconsistent with law or these Articles of Organization.
