ARTICLES OF ORGANIZATION

SECRETARY OF STATE I hereby certify that I have elected to form a limited liability company under the laws of limited the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. I further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

ARTICLE I

NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the limited liability company shall be **THE KINGDOM COMPANIES**, **L.L.C**, and its principal office and mailing address shall be 2025 Indian Springs Drive, Jacksonville, Florida 32246, but it shall have the power and authority to establish branch offices at any other place or places as the member(s) may designate.

ARTICLE II

To enter into and make all necessary contracts for its business with any person, entity, partnership, association, corporation, domestic or foreign, or of any domestic or foreign, state, government, or governmental authority, or of any political or administrative subdivision, or department, and to perform and carry out, assign, cancel, or rescind any of such contracts.
- 5.
