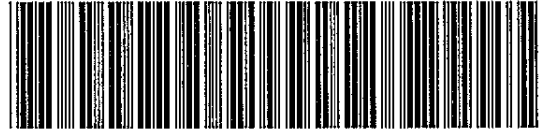


ARTICLE II
