## ARTICLES OF ORGANIZATION OF

### TARRAGON SOUTH COMMUNITY DEVELOPMENT, LLC, A Florida limited liability company

**ARTICLE I – Name:** The name of this limited liability company is Tarragon South Community Development, LLC (the "Company").
