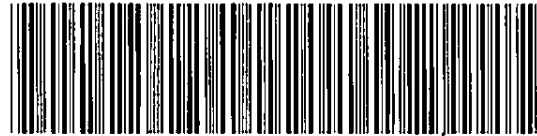

Pursuant to the provisions of Section 605.0202, Florida Statutes, as amended, the undersigned limited liability company, NAS Commercial Park, LLC, adopts the following Amended and Restated Articles of Organization. This Company's Articles of Organization were filed on April 23, 2004. The Company's Articles of Organization were previously amended and restated on July 12, 2004. Document Number L04000032339.

ARTICLE I - NAME

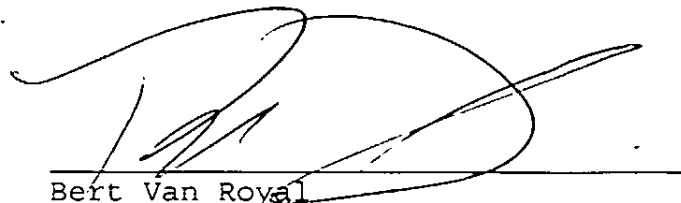
