
ARTICLE VI

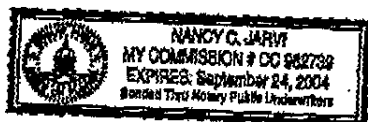
