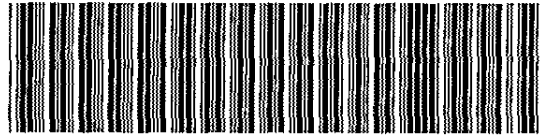

ARTICLE I - Name
