#### ARTICLES OF ORGANIZATION

#### FOR

#### ARTICLE I - NAME

The name of the Limited Liability Company is: GULF COAST VENTURES MI. LLC

#### **ARTICLE II - ADDRESS**

The mailing address and street address of the principal office of the Limited Liability Company is: Presidential Circle, 4000 Hollywood Blvd., Ste. 435 South, Hollywood, FL 33021.

#### **ARTICLE III - DURATION**

The period of duration for the Limited Liability Company shall be perpetual.

#### **ARTICLE IV - MEMBER SHARES**
