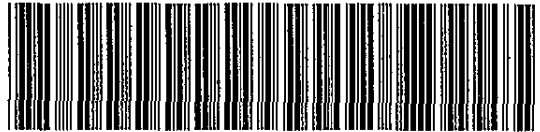



**MANAGEMENT OF THE COMPANY**


