ARTICLES OF ORGANIZATION

OF

BELL & MELAMED, LLC



The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **BELL & MELAMED**, **LLC**, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 1451 West Cypress Creek Road, Suite 300, Fort Lauderdale, Florida 33309 and the mailing address shall be the same.
