**ARTICLES OF ORGANIZATION
OF
SARENO, L.L.C.**

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statutes Chapter 608, entitled the Florida Limited Liability Act, do hereby adopt the following Articles of Organization:

**ARTICLE I.
NAME**


**ARTICLE X.
OPERATING AGREEMENT**

For purposes of these Articles of Organization and any other matter relating to the Company, the Operating Agreement of the Company shall be deemed the Regulations of the Company pursuant to appropriate provisions of Florida Statutes and the terms "Operating Agreement" and "Regulations" may be used interchangeably.

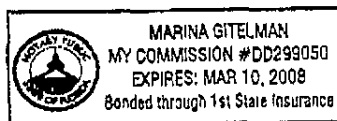


