ARTICLES OF ORGANIZATION

The undersigned, being the duly authorized member and sole Manager, desiring to form a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is H&K Strategic Communications LLC (the "Company").

ARTICLE VII. MEMBERS RIGHTS TO CONTINUE BUSINESS

The right, if given, of the remaining members of the Company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event that terminates the continued membership of a member in the Company will be as provided in the Operating Agreement of the Company.

ARTICLE VIII. MANAGEMENT

The Company affairs will be conducted, carried on, and managed by one (1) Manager, who will retain such position until removed and replaced by the Members of the Company as provided in the Operating Agreement of the Company. The Manager will have the obligations and responsibilities described in the Operating Agreement of the Company. The Manager will serve in that capacity until removed by the Members or until its successor is duly elected and qualified.

ARTICLE IX. OPERATING AGREEMENT

The power to adopt, alter, amend, or repeal the Operating Agreement of the Company will be vested in the members of the Company.
