ARTICLE 1
NAME

The name of the Limited Liability Company is: Security Storage Mobile Services Company, LLC.

ARTICLE 2
DURATION

The duration of this limited liability company is perpetual from the date of commencement of the limited liability company's existence. The date and time of commencement of the limited liability company's existence is the time of filing of the articles of organization by the Department of State of the State of Florida.

No person may be admitted as an additional member without the unanimous consent of the members. If such person is admitted, he or she shall be subject to the obligations and limitation in the

Regulations and Operating Agreement of the limited liability company, as amended for the additional members.




