ARTICLE VII- LIMITATION ON AUTHORITY

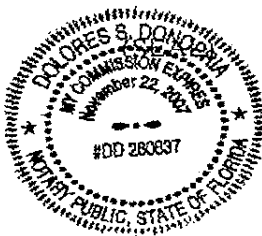

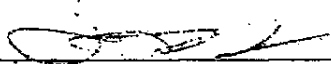
