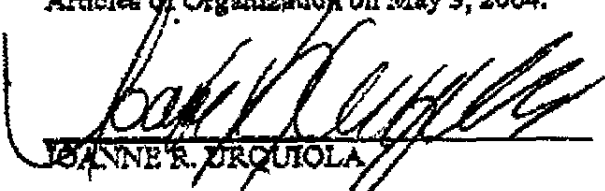
Article V. Management

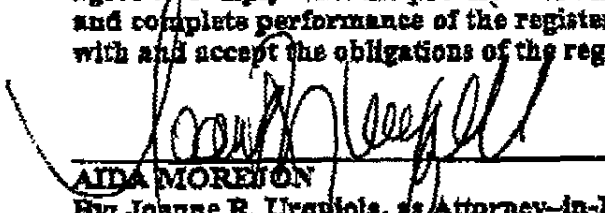
