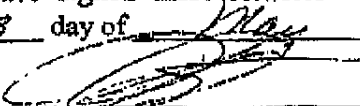
**ARTICLE VII — Admission of Additional Members:**

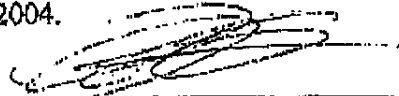
