ARTICLES OF ORGANIZATION
OF
RMB PROPERTY DEVELOPMENT GROUP, LLC

The undersigned, desiring to form a limited liability company under the Florida Limited Liability Company Act, Section 608.40 - 608.514, Florida Statutes, does hereby make acknowledge and file these Articles of Organization.

Article I
Name

The name of the limited liability company is RMB PROPERTY DEVELOPMENT GROUP, LLC (the "Company").

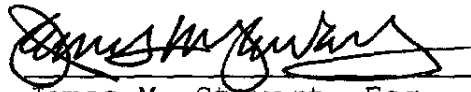
Article VII
