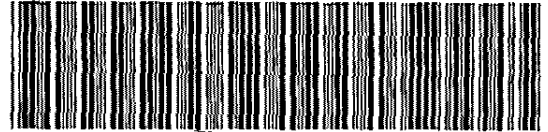

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I**  
**NAME**

The name of this Limited Liability Company shall be IMAJIN DESIGN, LLC (hereinafter "L.L.C.").

**ARTICLE II**  
**ADDRESS**

The mailing address and street address of the principal office of the L.L.C. is 661 Jamestown Blvd., #1084, Altamonte Springs, Florida 32714.

**ARTICLE III**  
**DURATION**

#### ADMISSION OF NEW MEMBERS

#### ARTICLE IX AMENDMENT

This L.L.C. reserves the right to amend or repeal any provisions contained in these Articles of Organization, or any amendment hereto, and any right conferred upon the members is subject to this reservation.


