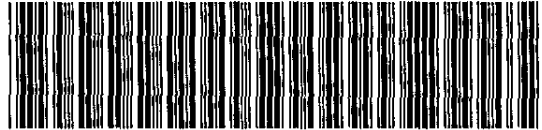

At a meeting of Alligator Properties LLC held December 15, 2004, for which notice was waived and at which all members were present, the following action was approved unanimously:

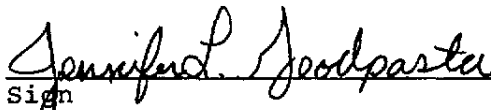
As of the date above, Alligator Properties LLC is dissolved, as its business is concluded.
