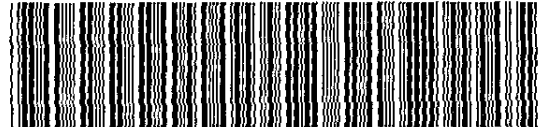

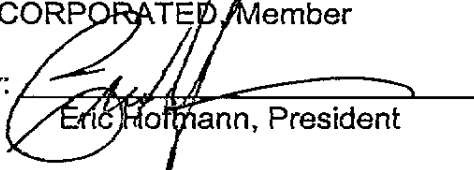

- FIRST:** The name and address of this corporation is **BOUNY ST., LLC**, 880 Mandalay Avenue, Unit C42, Clearwater, Florida 33767.
- SECOND:** The date of the adoption of these Articles of Dissolution is 7 February 2006.
- THIRD:** The dissolution of the Limited Liability Company was a unanimous agreement of all members. 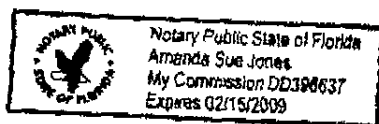
