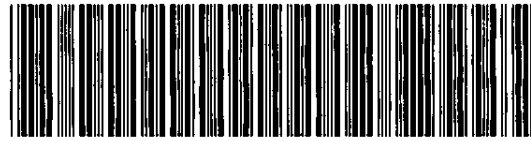


The undersigned constitute the members of SRP III, LLC, a Florida limited liability company.


The members unanimously approve the dissolution of the LLC because its only asset, real property, was conveyed to a third party for valuable consideration.
