The name of the limited liability company is: INLAND BAY HOLDINGS LLC

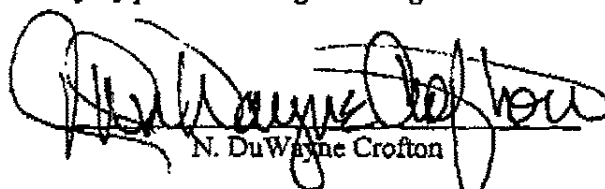
#### ARTICLE II. ADDRESS

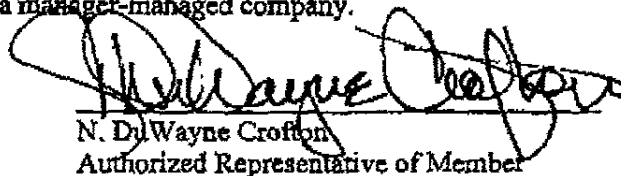
