ARTICLES OF ORGANIZATION

OF

TALENA BLUE, LLC

The undersigned certify that we have associated ourselves together for the purpose of becoming a Limited Liability Organization under the laws of the State of Florida. Florida Statute 608- Florida Limited Liability Organization Act, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the Limited Liability Organization.

ARTICLE I

The name of the Limited Liability Organization shall be TALENA BLUE, LLC (the "Limited Liability Organization").

ARTICLE II STREET ADDRESS OF PRINCIPAL OFFICE

The street address of the principal office of the Limited Liability Organization shall be located at 2588 SW 27TH AVE., MIAMI FL 33133, County of Miami-Dade, State of Florida, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

ARTICLE III MAILING ADDRESS

The mailing address for the Limited Liability Organization shall be 2588 SW 27 AVE., MIAMI, FL 33133.

ARTICLE IV INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The address of the initial registered office of the Limited Liability Organization is 2588 SW 27 AVE., MIAMI, FL 33133, County of Miami-Dade, and the name of the company's initial Registered Agent for service of process in the State of Florida, at that address is CONSULTING SERVICES OF SOUTH FLORIDA, INC..

ARTICLE V PURPOSES AND POWERS

In addition to the powers authorized by the laws of the State of Florida for limited liability organizations, the general nature of the business or businesses to be transacted, and which the Limited Liability Organization is authorized to transact shall be as follows:

- 1. To engage in any activity or business authorized under the Florida Statutes.
- 2. In general, to carry on any and all incidental business; to have and exercise all the powers conferred by the laws of the State of Florida, and to do any and all things set forth in these Articles to the same extent as a natural person might or could do.
- 3. To purchase or otherwise acquire, undertake, carry on, improve, or develop, all or any of the business, goodwill, rights, assets, and liabilities of any person, firm, association, or corporation carrying on any kind of business of a similar nature to that which this Limited Liability Organization is authorized to carry on, pursuant to the provisions of these Articles; and to hold, utilize, and in any manner dispose of the rights and property so acquired.
- 4. To enter into and make all necessary contracts for its business with any person, entity, partnership, association, corporation, domestic or foreign, or of any domestic or foreign state, government, or government authority, or of any political or administrative subdivision, or department, and to perform and carry out, assign, cancel or rescind any of such contacts.
- 5. To exercise all or any of the Limited Liability Organization powers, and to carry out all or any of the purposes, enumerated in these Articles and otherwise granted or permitted by laws, while acting as agent, nominee, or attorney-in-

fact for any person or corporations, and perform any service under contract or otherwise for any corporation, joint stock company, association, partnership, firm, syndicate, individual, or other entity, and in this capacity or under this arrangement develop, improve, stabilize, strengthen, or extend the property and commercial interest of the property and to aid, assist, or participate in any lawful enterprise in connection with or incidental to the agency, representation, or service, and to render any other service or assistance it may lawfully do under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of the limited liability companies for profit.

5. To do everything necessary, proper, advisable, or convenient for the accomplishment of any of the purposes, or the attainment of any of the objects, or the furtherance of any of the powers set forth in these Articles, either alone or in association with other incidental or pertaining to, or going out of, or connected with its business or powers, provided the same shall not be inconsistent with the laws of the State of Florida.

The several clauses contained in this statement if the general nature of the business or businesses to be transacted shall be construed as both purposes and powers of this Limited Liability Organization, and statements contained in each clause shall, except as otherwise expressed, be in no way limited or restricted by reference to or inference from the terms of any other clause. They shall be regarded as independent purpose and powers.

Nothing contained in these Articles shall be deemed or construed as authorizing or permitting, or purporting to authorize or permit the Limited Liability Organization to carry on any business, exercise any power, or do any act which a Limited Liability Organization may not, under Florida laws, lawfully carry on, exercise, or do.

ARTICLE VI DURATION

The term and duration of the Limited Liability Organization shall be perpetual, unless terminated in accordance with the Operating Agreement of the Limited Liability Organization or otherwise terminated in accordance with law.

ARTICLE VII CONTINUATION AFTER INVOLUNTARY TERMINATION

The business of the Limited Liability Organization may be continued after the death, bankruptcy, insanity, expulsion, withdrawal or dissolution of a Member of the Limited Liability Organization, or after the occurrence of any other event causing the involuntary dissolution of the Limited Liability Organization if, within ninety (90) days after such event, the remaining or surviving Members of the Limited Liability Organization unanimously elect to continue the business of the Limited Liability Organization.

ARTICLE VIII MEMBERS AND MANAGERS

The Limited Liability Organization shall have one or more members (the "Members"). The name and address of the initial Members are:

ARTICLE IX MEMBERSHIP RESTRICTIONS

Members shall have the right to admit new Members by unanimous consent. Contributions required of new Members shall be determined as of their time of admission to the Limited Liability Organization.

A member's interest in the Limited Liability Organization shall be considered personal property, notwithstanding the actual nature of the assets owned by the Limited Liability Organization, and may not be sold or otherwise transferred except with unanimous written consent of all existing Members.

ARTICLE X CAPITAL CONTRIBUTIONS

Capital contributions in the amount of \$1,000.00 cash shall be paid to the Limited Liability Organization by the members on the following amounts: Hernan D. Guerrero 900.00 (90%) and Silvia P. Barreto, \$100.00 (10%). Additional contributions will be made as required for investment purposes, as determined by unanimous consent of the members. Members will make contributions in their proportionate shares.

ARTICLE XI PROFITS AND LOSSES

A) Profit sharing. The members shall be entitled to the net profits arising from the operation of the Limited Liability Organization business that remain after the payment of the expenses of conducting the business of the Limited Liability Organization. Each member shall be entitled to its proportionate share of the profits. The distributive share of the profits shall be determined and paid to the members each year on the anniversary date of the commencement of business of the Limited Liability Organization, the month and the day of the commencement date being the date if the filing of these Articles.

B) Losses. All losses that occur in the operation of the Limited Liability Organization business shall be paid out of the capital of the Limited Liability Organization and the profits of the business, or, if these sources are insufficient to cover such losses, by the members in their proportionate shares.
