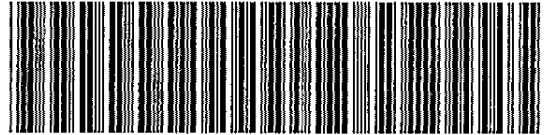

WHEREAS, the Articles of Organization for OXFORD PARTNERS, LLC ("Company") were filed May 7, 2004, by Jeffrey R. Biales;

WHEREAS, Jeffrey R. Biales was named in the Articles as the initial registered agent and initial managing member of the Company; and

WHEREAS, Jeffrey R. Biales has assigned his entire interest in the Company and resigned as the registered agent and managing member of the Company;

WHEREAS, the parties desire to amend the Articles of Organization to reflect these changes and to designate a new manager, a new registered agent and new addresses;

NOW THEREFORE, pursuant to the provisions of the Florida Limited Liability Company Act, OXFORD PARTNERS, LLC adopts the following Articles of Amendment to its Articles of Organization:

1. The Articles of Organization for OXFORD PARTNERS, LLC were filed on May 7, 2004.

2. Article II of the Articles of Organization is hereby amended in its entirety to read as follows:

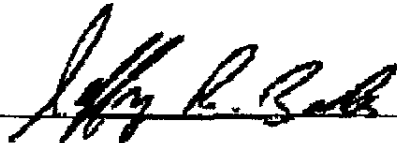
4. Article IV of the Articles of Organization is hereby amended in its entirety to read as follows:

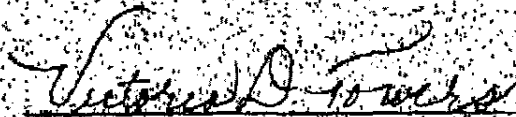
